*Map Manufacturer identifiers to Accession Numbers*

---

## Description

IlluminaHumanMethylation450kACCNUM is an R object that contains mappings between a manufacturer's identifiers and manufacturers accessions.

## Details

For chip packages such as this, the ACCNUM mapping comes directly from the manufacturer. This is different from other mappings which are mapped onto the probes via an Entrez Gene identifier.

Each manufacturer identifier maps to a vector containing a GenBank accession number.

IlluminaHumanMethylation450kALIAS2PROBE

*Map between Common Gene Symbol Identifiers and Manufacturer Identifiers*

---

### Description

IlluminaHumanMethylation450kALIAS is an R object that provides mappings between common gene symbol identifiers and manufacturer identifiers.

### Details

Each gene symbol is mapped to a named vector of manufacturer identifiers. The name represents the gene symbol and the vector contains all manufacturer identifiers that are found for that symbol. An NA is reported for any gene symbol that cannot be mapped to any manufacturer identifiers.

This mapping includes ALL gene symbols including those which are already listed in the SYMBOL map. The SYMBOL map is meant to only list official gene symbols, while the ALIAS maps are meant to store all used symbols.

### Description

Welcome to the IlluminaHumanMethylation450k.db annotation Package. The purpose of this package is to provide detailed information about the IlluminaHumanMethylation450k platform. This package is updated biannually.

### Description

This is a static map that returns the genome build for the probes in the DB.

### Details

Usually this will be number between 1 and something resembling infinity.

 IlluminaHumanMethylation450kCHR

*Map Manufacturer IDs to Chromosomes*


---

### Description

IlluminaHumanMethylation450kCHR is an R object that provides mappings between a manufacturer identifier and the chromosome that contains the gene of interest.

### Details

Each manufacturer identifier maps to a vector of chromosomes. Due to inconsistencies that may exist at the time the object was built, the vector may contain more than one chromosome (e.g., the identifier may map to more than one chromosome). If the chromosomal location is unknown, the vector will contain an NA.

Mappings were based on data provided by: Entrez Gene <ftp://ftp.ncbi.nlm.nih.gov/gene/DATA> With a date stamp from the source of: 2010-Sep7

**Description**

`IlluminaHumanMethylation450kCHRENGTHS` provides the length measured in base pairs for each of the chromosomes.

**Details**

This is a named vector with chromosome numbers as the names and the corresponding lengths for chromosomes as the values.

Total lengths of chromosomes were derived by calculating the number of base pairs on the sequence string for each chromosome.

 IlluminaHumanMethylation450kCHRLOC

*Map Manufacturer IDs to Chromosomal Location*

---

### Description

IlluminaHumanMethylation450kCHRLOC is an R object that maps manufacturer identifiers to the starting position of the gene. The position of a gene is measured as the number of base pairs.

The CHRLOCEND mapping is the same as the CHRLOC mapping except that it specifies the ending base of a gene instead of the start.

### Details

Each manufacturer identifier maps to a named vector of chromosomal locations, where the name indicates the chromosome. Due to inconsistencies that may exist at the time the object was built, these vectors may contain more than one chromosome and/or location. If the chromosomal location is unknown, the vector will contain an NA.

Chromosomal locations on both the sense and antisense strands are measured as the number of base pairs from the p (5' end of the sense strand) to q (3' end of the sense strand) arms. Chromosomal locations on the antisense strand have a leading "-" sign (e. g. -1234567).

Since some genes have multiple start sites, this field can map to multiple locations.

IlluminaHumanMethylation450kCOLORCHANNEL is an R object that provides mappings between a manufacturer identifier and the color channel for the assay for that locus

**Details**

Value is a simple Grn or Red for each probe, based simply on the Illumina manifest,

### Details

Simple probe mapping to CpG coordinate within the human genome, Build 37, as defined by Illumina.

Map a probe ID to CpG island with which it is associated, and find what sort of relationship the probe has to said island (in it, shore, etc.)

### Details

Map a probe ID to the CpG island with which it is associated.

### Details

Probe mapping to CpG density within the human genome, Build 36, as defined by Illumina.

IlluminaHumanMethylation450kDESIGN

*Probe design type for HumanMethylation450k arrays*

---

### Description

IlluminaHumanMethylation450kDESIGN provides a mapping from probe ID to the design type of that probe. On 27k arrays, all probes had the same chemistry in the sense that paired allelic probes always fluoresced in the same channel. On the newer 450k arrays, there are probes of the 27k design (Design I), but there are also probes which are extended base-by-base with either Cy5 or Cy3 fluorophores, leading to a differential fluorescence in the two channels. This provides a dense method of assaying methylation at closely spaced CpG bases, but also requires some accommodation in preprocessing and detection calls. By using a mapped database table to keep track of which probes are Design I vs II, the 'methyumi' package is able to quickly preprocess and later normalize the two chemistries in a fashion most appropriate to each.

### Details

The map returns either a 'I' or 'II' depending on probe chemistry.

### Details

This object is a simple mapping of Entrez Gene identifiers <http://www.ncbi.nlm.nih.gov/entrez/query.fcgi?db=gene> to Ensembl gene Accession Numbers.

Mappings were based on data provided by BOTH of these sources: <http://www.ensembl.org/biomart/martview/> <ftp://ftp.ncbi.nlm.nih.gov/gene/DATA>

This mapping is a combination of NCBI to ensembl IDs from BOTH NCBI and ensembl. Users who wish to only use mappings from NCBI are encouraged to see the ncbi2ensembl table in the appropriate organism package. Users who wish to only use mappings from ensembl are encouraged to see the ensembl2ncbi table which is also found in the appropriate organism packages. These mappings are based upon the ensembl table which is contains data from BOTH of these sources in an effort to maximize the chances that you will find a match.

## Description

IlluminaHumanMethylation450kENTREZID is an R object that provides mappings between manufacturer identifiers and Entrez Gene identifiers.

## Details

Each manufacturer identifier is mapped to a vector of Entrez Gene identifiers. An NA is assigned to those manufacturer identifiers that can not be mapped to an Entrez Gene identifier at this time.

If a given manufacturer identifier can be mapped to different Entrez Gene identifiers from various sources, we attempt to select the common identifiers. If a consensus cannot be determined, we select the smallest identifier.

## Description

IlluminaHumanMethylation450kENZYME is an R object that provides mappings between manufacturer identifiers and EC numbers.

## Details

Each manufacturer identifier maps to a named vector containing the EC number that corresponds to the enzyme produced by that gene. The name corresponds to the manufacturer identifier. If this information is unknown, the vector will contain an NA.

Enzyme Commission numbers are assigned by the Nomenclature Committee of the International Union of Biochemistry and Molecular Biology <http://www.chem.qmw.ac.uk/iubmb/enzyme/> to allow enzymes to be identified.

An Enzyme Commission number is of the format EC x.y.z.w, where x, y, z, and w are numeric numbers. In IlluminaHumanMethylation450kENZYME2PROBE, EC is dropped from the Enzyme Commission numbers.

Enzyme Commission numbers have corresponding names that describe the functions of enzymes in such a way that EC x is a more general description than EC x.y that in turn is a more general description than EC x.y.z. The top level EC numbers and names are listed below:

IlluminaHumanMethylation450kENZYME2PROBE is an R object that maps Enzyme Commission (EC) numbers to manufacturer identifiers.

## Details

Each EC number maps to a named vector containing all of the manufacturer identifiers that correspond to the gene that produces that enzyme. The name of the vector corresponds to the EC number.

Enzyme Commission numbers are assigned by the Nomenclature Committee of the International Union of Biochemistry and Molecular Biology <http://www.chem.qmw.ac.uk/iubmb/enzyme/> to allow enzymes to be identified.

An Enzyme Commission number is of the format EC x.y.z.w, where x, y, z, and w are numeric numbers. In IlluminaHumanMethylation450kENZYME2PROBE, EC is dropped from the Enzyme Commission numbers.

Value is a simple TRUE or FALSE for each probe.

### Description

IlluminaHumanMethylation450kGENENAME is an R object that maps manufacturer identifiers to the corresponding gene name.

### Details

Each manufacturer identifier maps to a named vector containing the gene name. The vector name corresponds to the manufacturer identifier. If the gene name is unknown, the vector will contain an NA.

Gene names currently include both the official (validated by a nomenclature committee) and preferred names (interim selected for display) for genes. Efforts are being made to differentiate the two by adding a name to the vector.

---

## Description

IlluminaHumanMethylation450kGO is an R object that provides mappings between manufacturer identifiers and the GO identifiers that they are directly associated with.

## Details

Each Entrez Gene identifier is mapped to a list of lists. The names on the outer list are GO identifiers. Each inner list consists of three named elements: GOID, Ontology, and Evidence.

The GOID element matches the GO identifier named in the outer list and is included for convenience when processing the data using 'lapply'.

The Ontology element indicates which of the three Gene Ontology categories this identifier belongs to. The categories are biological process (BP), cellular component (CC), and molecular function (MF).

The Evidence element contains a code indicating what kind of evidence supports the association of the GO identifier to the Entrez Gene id. The evidence codes in use include:

IMP: inferred from mutant phenotype

IGI: inferred from genetic interaction

IPI: inferred from physical interaction

ISS: inferred from sequence similarity

IDA: inferred from direct assay

IEP: inferred from expression pattern

The physical location of each band on a chromosome can be obtained from another object named "organism"CYTOLOC in a separate data package for human(humanCHRLOC), mouse(mouseCHRLOC), and rat(ratCHRLOC).
